

# Organizational Changes and Executive Officers and Corporate Executive Fellows Appointments

Kao Corporation (the "Company" – *Ticker Code: 4452*) would like to announce the following organizational changes and Executive Officers and Corporate Executive Fellows appointments, effective January 1, 2025.

Kao Group Mid-term Plan "K27" is progressing as planned. To achieve the success of "K27" and further accelerate global growth, the Company is clarifying regional responsibilities and enabling swift decision-making by integrating business and sales into a unified "Global Consumer Care Business." Kao Group Customer Marketing Co., Ltd. will expand its activities as the division promoting sales in Asia region. Meanwhile, in Europe and the Americas, the regional heads will take the lead in advancing operations across product development, branding, marketing, and sales.

Additionally, to further maximize cross-business activities, the Company will establish a new "Business Connected." This division will focus on strengthening the Kao brand's professional-use business (Kao Professional Services Company, Limited), advancing the experiential direct-to-consumer business for the overall Kao brand (My Kao Mall), and accelerating the development of co-creation initiatives with partners leveraging Kao's technologies.

Furthermore, beyond structural reforms, the Company aims to maximize the effective and efficient use of group capital by integrating accounting and financial functions. This integration will enhance cross-functional capabilities from a financial perspective, including the formulation of capital strategies.

The Enterprise Information Solutions and the DX Strategy will be integrated into a single Digital Strategy to streamline decision-making and concentrate resources. This integration will accelerate digital transformation across all divisions and businesses, including marketing and the supply chain.

With the new organizational structure and executive officer structure, the Company will strongly and swiftly execute the *Global Sharp Top* Strategy to achieve K27.
